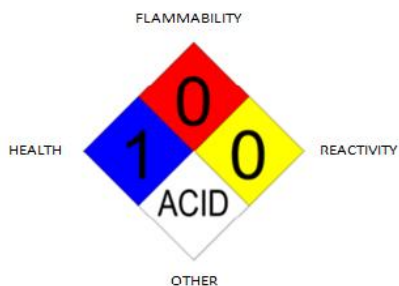

#### 4. First-Aid Measures
