#### 4. First-Aid Measures

taking care not to contaminate eyes. Seek medical attention if irritation develops or persists.

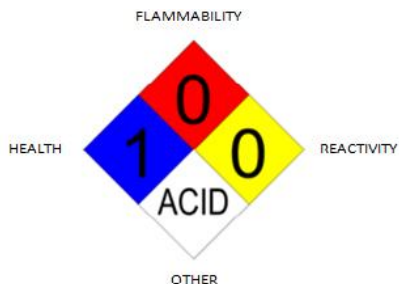
