INTENDED USE

The Eagle Biosciences Human CCL20/MIP3 ELISA Assay Kit is intended for the quantitative measurement of CCL20/MIP3 in human serum/plasma, urine, and more. The CCL20/MIP3 ELISA Assay Kit is for research use only and not to be used in diagnostic procedures.

REAGENT PREPARATION

Washing Buffer (1x) Preparation:


Pour entire contents (50mL) of the **Washing Buffer Concentrate (10x)** into a clean 500 mL graduated cylinder. Bring to final volume of 500 mL with glass-distilled or deionized water. Transfer to a clean wash bottle and store at 2 to 25°C.

Standard Curve Preparation:

S1 to S7 and S0 are ready to use for serum and plasma.

For other sample types, prepare the standard curve with whatever buffer (SPB, Sample Prepared Buffer) is used to prepare the sample, such as cell culture supernatant, tissue grinding liquid, cell lysate, etc. For urine samples use AB (Assay Buffer) to prepare standard curve.

The Human CCL20 Standard 80,000 pg/mL 30 μ L + 270 μ L SPB serves as the high standard (8,000 pg/mL). Pipette 200 μ L of SPB into each tube. Use the high standard to produce a 1:2 dilution series. Mix each tube thoroughly before the next transfer. SPB serves as the zero standard (0 pg/mL).


ASSAY PROCEDURE

Bring all reagents and samples to room temperature before use.

- 1. Prepare all reagents and working standards as directed in the previous sections.
- 2. Remove excess **CP** (**Coated Plate**) strips from the plate frame, return them to the foil pouch and reseal.
- 3. Add 50 µL of AB (Assay Buffer) to each well.
- 4. Add 50 μ L or 10 μ L of **Standard or Sample** per well. Ensure reagent addition is uninterrupted and completed withing 15 minutes.
- 5. Add 50 μL of **DA (Detect Antibody)** to each well.
- 6. Cover with an **SF** (**Sealer Film**). Incubate at room temperature (18 to 25°C) for 1 hour on a microplate **shaker** set to 500 rpm.
- 7. Aspirate each well and **wash**, repeating the process four times. Wash by filling each well with WB (Washing Buffer 300 µL). Complete removal of liquid at each step is essential to good performance. After the last wash, remove any remaining WB (Washing Buffer) by aspirating or decanting. Invert the plate and **blot** it against clean paper towels.
- 8. Add 100 μL of SH (Streptavidin-HRP) to each well.
- 9. Cover with a new **SF** (**Sealer Film**). Incubate at room temperature (18 to 25°C) for 30 min on a microplate **shaker** set at 500 rpm.
- 10. Repeat aspiration/wash as in step 7.
- 11. Add 100 μL of **TS (TMB Substrate)** to each well. Incubate for 5-30 minutes at room temperature.
- 12. Add 100 µL of SS (Stop Solution) to each well.
- 13. Determine the optical density within 30 minutes, using a microplate **reader** set to 450 nm corrected with 570 nm or 630 nm.

SENSITIVITY

The minimum detectable dose (MDD) of human CCL20 is typically less than 8.58 pg/mL (50 μ L of sample volume) or 12.19 pg/mL (10 μ L of sample volume).

The MDD was determined by adding two standard deviations to the mean optical density value of ten zero standard replicates and calculating the corresponding concentration.

PRECISION

Intra-assay Precision (Precision within an assay)

Three samples of known concentration were tested twenty times on one plate to assess intra-assay precision.

RECOVERY

The spike recovery was evaluated by spiking 3 levels of human CCL20 into healthy human serum samples. The un-spiked serum was used as a blank in this experiment. The recovery ranged from 121% to 128% with an overall mean recovery of 115%

LINEARITY

To assess the linearity of the assay, five samples were spiked with a high concentration of CCL20 in human serum and diluted with Sample Diluent to produce samples with values within the dynamic range of the assay.

The linearity ranged from 121% to 124% with an overall mean recovery of 123%.



SAMPLE VALUES

Serum/Plasma - Thirty samples from apparently healthy volunteers were evaluated for the presence of human CCL20 in this assay. No medical histories were available for the donors.
